Below please find out the necessary information for participating in the Affordability Initiative for 2020-2021 school year.

**NECESSARY FORMS:**

For purposes of determining Adjusted Gross Income, the prior year's tax return is used for calculating the deposit (2018). In the spring, the 2019 Form 1040 is submitted to set the actual tuition. Please submit your 2018 Form 1040 with this form (submission of the 1040 form is not necessary if the school is in possession of your most current 2018 1040 form).

**DEPOSIT:**

For applicants for the Affordability Initiative, the early security deposit of 10% of projected tuition is due on December 6, 2019, with another 10% due by January 27, 2020. To assist families with students already at Beit Rabban who are concerned about cash flow, by request, the current year tuition payments for November and January can be deferred until April and May when there are no scheduled payments.

If the family has a child or children not yet admitted into the school and the program only works for the family with all children in the school, the first deposit will be refundable if the child or children is/are not admitted. If a child is not admitted to the school, any payment that is made towards the Affordability Initiative that is above and beyond the regular deposit required will be returned to the family.

**DEADLINE:**

Please submit this form with your 2018 Form 1040 and your deposit by December 6, 2019. Please make all checks payable to Beit Rabban Day School and note children's name in the memo with deposit for 2020-2021 school year.
